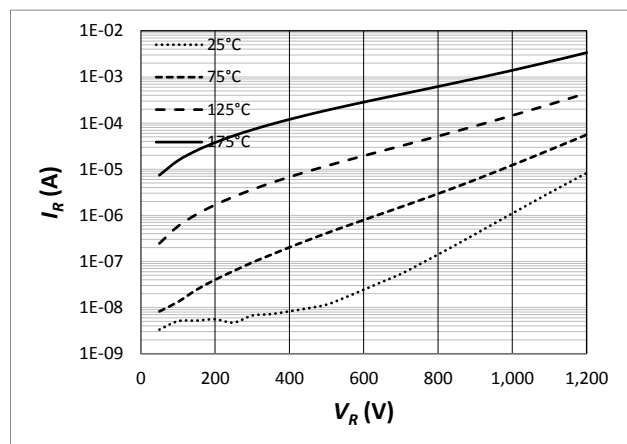

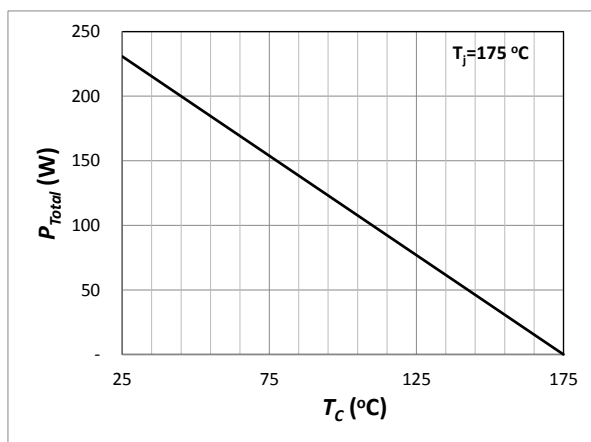
Forward Characteristics (parameterized on T_j)



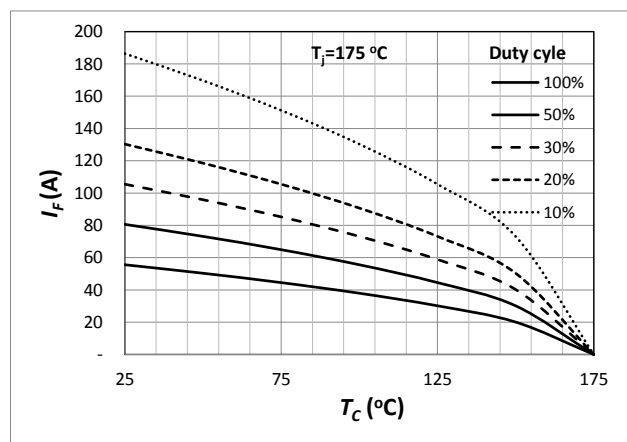
Reverse Characteristics (parameterized on T_j)



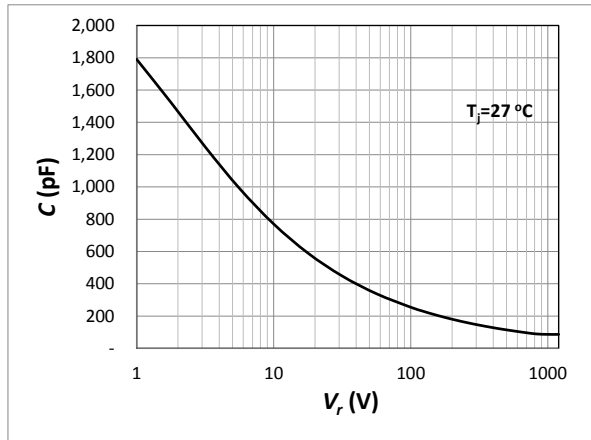

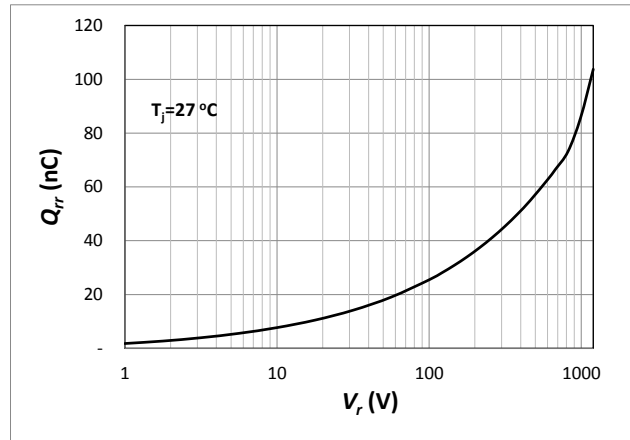

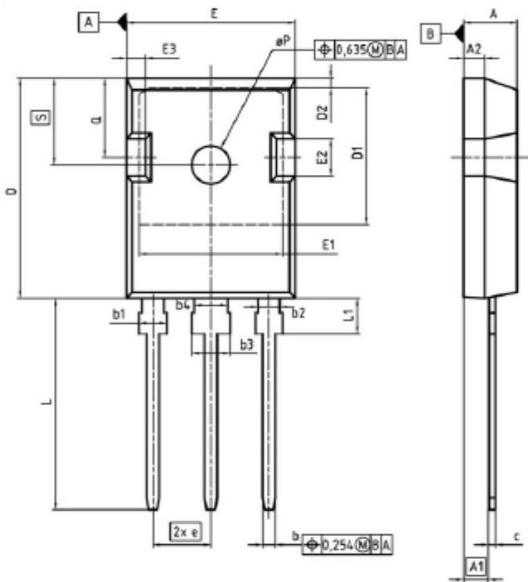
